This congregation is the largest of its kind in the world & we are proud to remember that our Federation has been holding Conferences every year since 1962. We know our members wait eagerly to attend the annual Conference as this is the opportunity to renew our bond with our Federation, meet former leaders, participate in academic discourses, take a stock of our activities in last year and to chart our movement program for the next year.

# **Delhi activities: GS met HRD & UGC officials**

Our General Secretary has stayed a good number of days in Delhi before & after the NEC meeting held in Kolkata on 21<sup>st</sup> September, 2014 to interact with the MHRD & UGC officers to take up the matters as mandated by the NEC meetings. The most urgent matter is that the UGC Decisions regarding Roll Out date & revised cap have not yet been notified as the HRD approval is still awaited. The last meeting was with Ms.Binita Thakur, PS to the Hon'ble Minister, HRD regarding the pending HRM approval of the decisions & an appointment we sought with the Hon'ble Minister. The General Secretary conveyed the agony of teachers regarding the long waited HRM approval and also the delay in granting an appointment to meet Hon'ble HRM.Ms.Thakur assured the General Secretary that she would look into the approval as early as possible and an appointment may be granted after 15<sup>th</sup> October,2014. The General Secretary also discussed all other issues wit Sri.R.P.Sisodia.Joint Secretary (Higher Education) and requested his help.

General Secretary requested Prof.Dr.Sandhu, Secretary, and UGC to expedite the UGC decision regarding Ph.D Regulations & parity between Teachers, Librarians &DPEs in respect of FDP schemes & granting major & Minor Projects to them.

# NEC meeting held on 21st September, 2014

NEC meeting was held in Indian Institute of Cultivation of Science at Jadavpur, Kolkata hosted by all affiliates of AIFUCTO in West Bengal. This is the 3<sup>rd</sup> NEC meeting of the year 2013-14.It was a highly attended meeting as almost all states sent their representatives to the meeting. The original meeting venue was Jadavpur University where the meeting could not be held due to students' movement protesting the unprecedented police actions in the midnight at the behest of Vice Chancellor of the University &beating of students, both girls & boys, who had been peacefully picketing demanding actions against some students who molested a girl student.

Prof.Tarun Patra, our President presided over the meeting. He initiated the meeting with a brief reporting on the incidents that led to the students' movement & shifting of the venue. All speakers in the meeting strongly protested the unfortunate decision of the VC to call police & apply force against peaceful students' movement for a justified cause.

# General Secretary's reporting of the developments after last NEC held in Faridabad, Harvana

The GS reported the decisions of the Secretariat meeting held in Delhi and the actions taken. He reported that there was no progress regarding the approval of UGC decisions to be given by the Hon'ble Minister, HRD.He also noted

that there was no appointment given by the office of The Hon'ble Minister to meet her thogh a request letter was sent one month back. He expressed deep disappointment for the prevailing situation. However, he expressed the hope that Hon'ble Minister, HRD would take actions to resolve the stalemate. However, he reported that he was discussing with the office of Hon'ble Minister & the office has expressed the hope that the matter would be resolved. The GS told them, in unambiguous terms, that a meeting with Hon'ble Minister is urgently required. GS also noted with acknowledgement that PCCTU leaders made representations to Hon'ble Minister on both the approval & appointment.GS told the meeting that he is in regular touch with Prof.Jagwant Singh & Prof.H.S. Walia to present the case to Hon'ble Minister during her visit to Chandigarh & Amritsar. Prof Walia submitted memorandum to her & also made press statement which were widely covered by the press,

The General Secretary also reported on the progress of RUSA and highlighted the importance of our sate affiliates to keep close contact with respective state govts. for proper implementation of RUSA.

GS requested the members of NEC to send detailed information about the status of higher education in respective state so that a comprehensive report may be prepared and published. This is necessary for an all India perspective and our future action program.

The NEC decided to form a committee to prepare a report on RUSA before the Conference, The report would be placed in the Conference. General Secretary in consultation with President named the members of the Committee. However, the committee may seek service of any other leader in the exercise.

The students were protesting the University inaction to punish the culprits who molested a girl The resolution demanded an inquiry to find out the responsible persons for this inhuman act & unequivocally demanded exemplary action against those persons.

# Rally protesting the entry of police in Jadavpur university & brutal police attack on the students

After the NEC meeting the NEC members joined a well attended rally of teachers of West Bengal. A street corner meeting was held after the rally. The rally was addressed by the NEC members from different states along with academicians of the state & leaders of affiliates of AIFUCTO.

# **Building Fund coupons**

Following the decision of the Secretariat meeting & as notified in the last Circular the coupons of Rs.200 for the building fund was distributed. Most states collected limited number of coupons & wanted to take the remaining coupons during the next Conference.
